After repeal of the NOVOD Board Act, 1983, the National Oilseeds & Vegetable Oils Development (NOVOD) Board has been wound up vide order dated 08.09.2016. The employees of the Board have been placed under a Surplus Staff Establishment (SSE) in this Ministry for their redeployment. A list of such surplus staff is enclosed. The employees are, therefore, available for placement in other organizations/ Offices/Divisions of DAC&FW.

2. It is requested that all out efforts may be made to suitably accommodate the above surplus staff on Top Priority both on administrative and humanitarian grounds. While sending requisition to Recruiting Agency for filling up the vacant post in above categories the same may be reported to the concerned Administrative Division of the Ministry and to the Surplus Staff Establishment so that the same may be filled from surplus staff with requisite approval of competent authority and also seeking NOC from DoPT, if required
3. You may kindly intimate the availability of similar or identical matching posting(s) as per the corresponding grade pay to adjust the surplus staff in your organization as listed on priority basis.
4. An early positive action in the matter shall be appreciated.

Order


Consequent upon winding up of the National Oilseeds and Vegetable Oils Development (NOVOD) Board, the following has been decided:-

1. The land and building of the NOVOD Board are transferred to the National Horticulture Board(NHB) temporarily, until further orders;
2. A Surplus Staff Establishment (SSE) comprising one officer (Section Officer/ Asstt Director), one Office Assistant, one UDC/LDC and one MTS is created under Oil Seeds Division, out of the manpower of NOVOD Board, to accommodate the employees of the NOVOD Board.
3. All employees of the NOVOD Board are hereby transferred to the Surplus Staff Establishment(SSE) till they are accommodated in NHB or any other organization/office/Division of DAC against vacancies or on need basis.
4. The permanent posts held by the employees are deemed to have been abolished and in lieu thereof supernumerary posts are deemed to have been created for the Surplus employees in Surplus Staff Establishment.
5. Salary, Leave salary and pension contribution of the surplus employees of the NOVOD Board, till their redeployment, will be borne by DAC. Necessary budget provision in this regard will



be made from the "grants-in-aid" provided by DAC&FW under NMOOP. Surplus Employees who joined on or after 01.04.2004 will continue to be covered under Defined Contribution Pension Scheme (New Pension Scheme).

6. A new account for operating salary, retirement benefits including pension of the NOVOD Board Employees, namely 'Salary, Pension and Retirement Benefit Account of NOVOD Board Employees' is hereby opened in DAC &FW. Director/Deputy Secretary (Oil Seeds) in the Oil Seeds Division will be the custodian of the account.

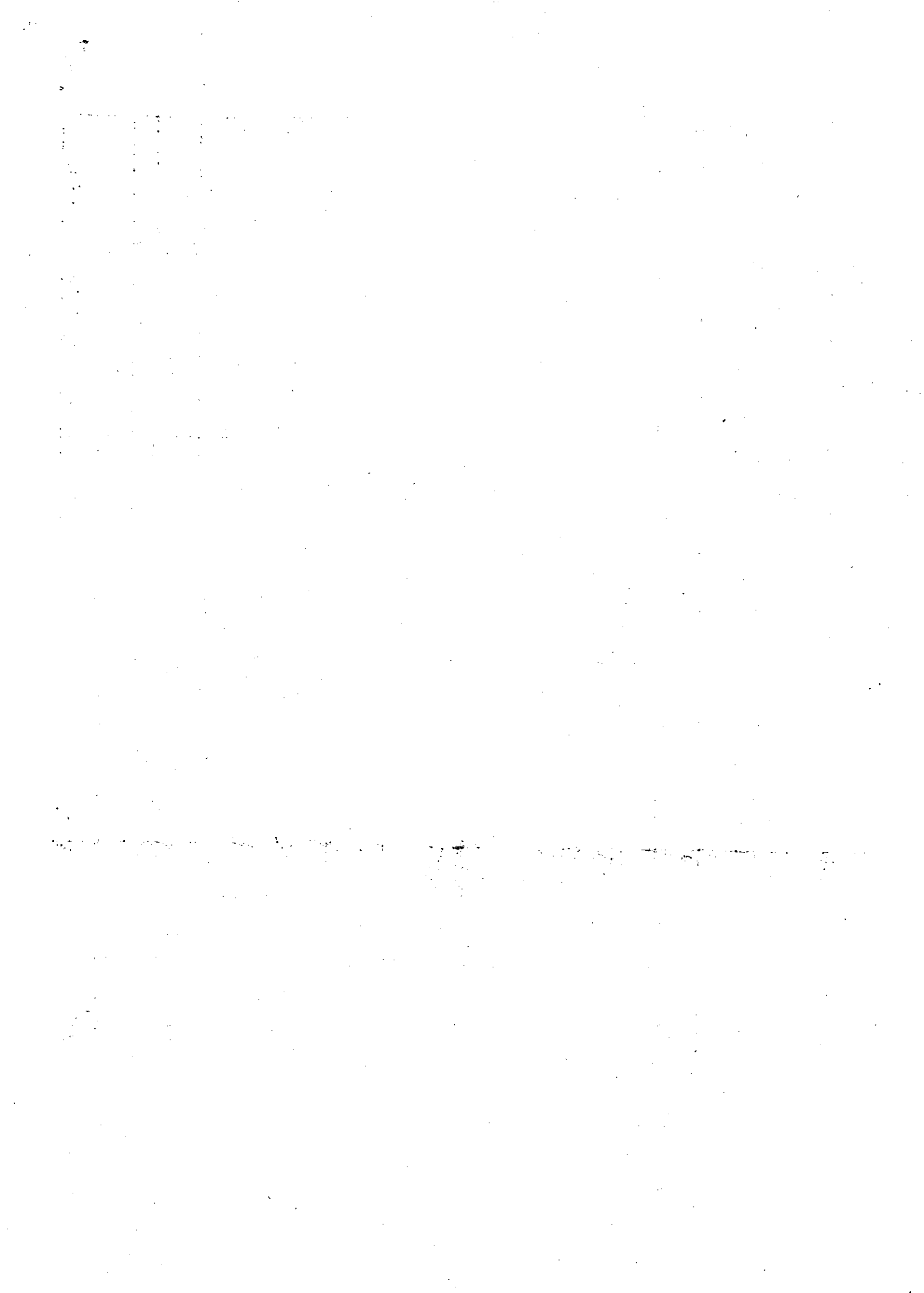

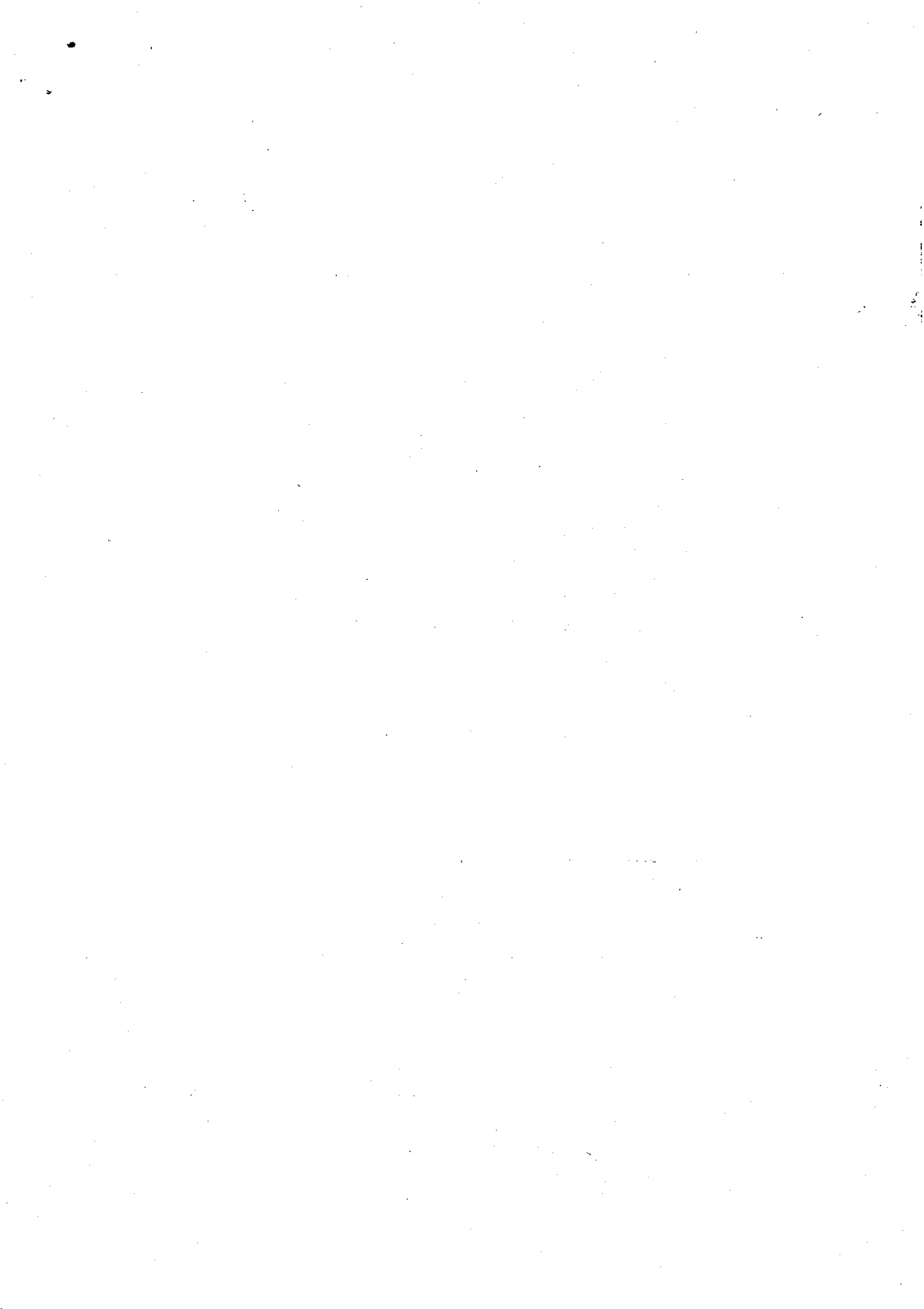
