Office Memorandum

Subject: Implementation of Direct Benefit Transfer (DBT) in all schemes of Department of Agriculture, Cooperation & Farmers Welfare (DAC&FW).

Reference: Letters No. (i) Z-11018/34/2016-IT dated 6th June, 2016.
(ii) 13-21/2016-PC(Pt) dated 29th June, 2016

As you are aware the scope of DBT has since been widened to cover all Central Sector and Centrally Sponsored Schemes, where benefits (in cash or kind) are transferred to individual beneficiaries. DBT Mission established under the Cabinet Secretariat has laid down 31st March 2017 as the time line for transition of all agriculture schemes to DBT mode. A DBT Cell under the Chairmanship of Additional Secretary (AD) has also been established in DAC&FW to take this initiative forward.

2. Vide letter under reference, all divisions had been requested to examine their schemes and programmes in the light of expanded scope of DBT and plan transition of the scheme to DBT mode. A questionnaire to assist programme Divisions on these lines is also attached as Annexure-I.

3. Analysis of some of our major schemes from stand point of funds flow and benefits has since been carried out and is attached as Annexure-II for your reference. Keeping in view the existence or otherwise of the IT platforms, following broad strategy has been planned for on-boarding of our schemes on DBT mode:-

(a) Centrally sponsored Schemes with existing IT Platforms with capability to capture Beneficiary details. Add required fields (as per Annexure-III) in the existing databases and integrate these with Central DBT Portal. This needs to be done on immediate basis.

(b) Centrally sponsored Schemes with existing IT Platforms but without capability to capture Beneficiary details. Modify existing data bases so as to enable capture of beneficiary details as per Annexure-II. NIC is also being asked to develop a central MIS for all Agriculture schemes. It has to be accomplished by December 31, 2016.

(c) Create appropriate IT platforms for Centrally Sponsored Schemes which do not have one at the moment.

(d) All Central sector schemes shall utilize PFMS portal of Controller General of Accounts, Ministry of Finance for entering their Aadhaar seeded beneficiary data with immediate effect.

4. Till the Centrally sponsored schemes are on-boarded through respective IT platforms, 'Aadhaar seeded beneficiary data' needs to be obtained from states and forwarded to DBT Mission on a monthly basis as per the Performa attached as Annexure-IV. It is requested to ensure that the timelines for implementation are adhered to.

5. It may also be impressed upon all States/UTs that all future releases for centrally sponsored schemes, post March 31st, 2017 would be based on Aadhaar linked data bases of beneficiaries.
