

The accounts of HIL shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provisions of CAG (DPC) Act 1971 and internal Audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and they will have the right to demand the production of books of accounts, vouchers and other papers/documents in this regard.


