In continuation of this Department's letter of even number dated 30.07.2015, I am directed to convey the sanction of the President of India for release of an amount of ₹ 1,13,00,000/- (Rupees One crore thirteen lakh only) to National Oilseeds & Vegetable Oil Development Board (NOVOD Board) for meeting the establishment and administrative expenditure during 2015-16 under Tree Borne Oilseeds (TBOs) of NMOOP during 2015-16.

4. The payment sanctioned above is also subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2919/P.11/60 dated the 9<sup>th</sup> October, 1964.

The accounts of NOVOD Board pertaining to Tree Borne Oilseeds schemes shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and they will have the right to demand the production of books of accounts, vouchers and other papers/documents in this regard.


