Sub.: Release of funds to National Seeds Corporation (NSC) under National Mission on Oilseeds and Oil Palm (NMOOP) 2015-16-reg.

Sir,

I am directed to convey the sanction of the President of India for release of the payment of ₹9,23,91,310/- (₹ Nine Crore twenty three lakhs ninety one thousand three hundred ten only), to NSC for the expenditure incurred towards supply of seed mini kits of different Oilseeds of different varieties to different States during Rabi 2014-15 and Summer-2015 under National Mission on Oilseeds and Oil Palm(NMOOP)2015-16.

2. The release is subject to terms & conditions laid down in the Administrative Approval issued vide letter No. 14-1/2015-CA-II dated 15.04.2015 and guidelines issued vide letter No. 7-2/2015-Oilseeds/CA dated 15.04.2015.

3. The expenditure is adjustable against the funds available under Demand No. 1-Department of Agriculture & Cooperation, Major Head- 2401 Crop Husbandry, 114- Development of Oilseeds, 15-Krishonnati Yojana-State Plan, 01-National Mission on Oilseeds and Oil Palm, 150131- Grant- in-aid-General for 2015-16.

4. The payment sanctioned above is also subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2919/P.11/60 dated the 9th October, 1964.

5. The accounts of NSC shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and they will have the right to demand the production of books of accounts, vouchers and other papers/documents in this regard.

6. This issues with the concurrence of the Finance Division of the Department of Agriculture & Cooperation vide their Diary No. 9979-FIS/AS&FA dated 29.5.2015.

7. This has been noted as per GFR Rule 212(4) (b) at serial No. 1/1 in the Register of Grants for 2015-16.
