

4. The payment sanctioned above is also subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2919/P.11/60 dated the 9th October, 1964.

5. The accounts of ICAR-DGR shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor-General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so and they will have the right to demand the production of books of accounts, vouchers and other papers/documents in this regard.

6. The implementing agency is requested to furnish the physical and financial progress report for which the funds have been utilized for implementation of the scheme and is also requested to furnish the Audited Utilization Certification (AUC) in the prescribed proforma GFR – 19(A) to this Department at the end of financial year.


