- Release of fund for 2<sup>nd</sup> instalment will be subject to submission of utilization certificate in GFR-19 A and progress report.
- The ICAR-IIOR will constitute monitoring team for the programme implementation by involving scientists/ officials of SAU/ ICAR/ State/DOD for the project period and submit the report at the end of each season.
